PROGRAMS AND REGULAR MONITORING HELP RESIDENTS RETAKE CONTROL OF THEIR LIVES AND BECOME INDEPENDENT AND SELF SUFFICIENT.

THC'S HOUSING WITH CARE PERMANENT SUPPORTIVE HOUSING (PSH) PROGRAM PROVIDES AFFORDABLE HOUSING WITH APPROPRIATE WRAPAROUND SUPPORTIVE SERVICES TO FAMILIES THAT HAVE A DISABILITY THAT PREVENTS THEM FROM LIVING INDEPENDENTLY AND AFFORDING MARKET RENT. HEAD OF HOUSEHOLDS PAY 30% OF THEIR TOTAL HOUSEHOLD INCOME TOWARDS MONTHLY RENT AND THE REMAINING RENTAL AMOUNT IS SUBSIDIZED THROUGH THE DISTRICT OF COLUMBIA
